KALISMAN V. FRIEDMAN

The Delaware Court of Chancery, in *Kalisman v. Friedman* (Apr. 17, 2013), ordered counsel for a company's board of directors and its special committee to provide to a dissident director copies of their communications with the company's other directors, as well as internal law firm communications.
