


# / Equal Justice Works and The Morrison & Foerster Foundation celebrate 20 years of partnership



#### **MELISSA FRYDMAN**

**Year:** 2000

Host Organization: Bay Area Legal Aid

City/State: Oakland, CA

Issue Area: Children/Youth

**Project Description:** Provide civil legal services to youth involved in the juvenile justice system to help them enforce their basic rights to education, health care and safe homes, and to help prevent them from committing future crimes.

Where are they now? After her Fellowship, Melissa continued to represent children as a Staff Attorney at Bay Area Legal Aid. She then joined Legal Services for Children as Senior Staff Attorney and Director of the Dependency Project. She served as an acting assistant professor with the Lawyering Program at New York University School of Law for three years. Melissa joined the University of Illinois in April 2010 as a Clinical Professor of Law to develop and direct the new Family Advocacy Clinic, which provides legal representation to parents and children in juvenile abuse and neglect cases. In Fall 2016, Melissa was named Director of Clinical Education at the University of Illinois. In this capacity, she oversees the entire clinical program, faculty, and staff.

**Project Description:** Provide comprehensive legal services to youth ages 12-22 in an effort to end domestic violence by working proactively with youth.

Where are they now? After her Fellowship, Suma continued at the Harriett Buhai Center for Family Law, working as a staff attorney until 2004. In September 2004, she took a position at the LA Center for Law and Justice (LACLJ) as a Teen Advocate/Family Law Attorney. She then moved on to supervise the Family Law Unit, coordinate LACLJ's pro bono program, assist in grant reporting, participate in community outreach and advocacy groups, and represent South Asian and teen clients. She served as Associate Director for LACLJ from April 2013 to September 2014. In January 2017, Suma became an adjunct professor at USC's Suzanne Dworak-Peck's School of Social Work. Suma is currently the acting interim managing attorney at Break the Cycle.

Suma has served as the Vice President of the Board of Trustees of the Asian Pacific Women's Center, a transitional domestic violence shelter; the Board President of the South Asian Bar Association of Southern California; and she helped found the South Asian Bar Association's Public Interest Foundation in 2003. Suma received the 2015 South Asian Bar Association of Southern California Public Interest Foundation's Public Service award, the 2011 University of Southern California Public Interest Law Foundation's Public Interest Attorney of the Year award, the 2009 Domestic Violence Prevention/Intervention award from the Los Angeles County Domestic Violence Council, and the Community Activism award from the South Asian Network in 2008.

**Project Description:** Provide low-income, immigrant parents with high quality legal services on education-related issues; train community residents about their education-related rights; and catalyze civic activism around improving Brooklyn's worst public schools.

Where are they now? First elected in 2013, Denise is currently the Honorable Civil Court Judge of the 7th District in the borough of Manhattan. She also has her own law office where she represents individual clients, small businesses, and corporations in criminal defense, derivative actions, matrimonial, family, and landlord-tenant matters.

Where are they now? After her Fellowship, Michele joined Morrison & Foerster as an associate in the San Diego office. Currently, Michele is a Professor of Law at Golden Gate University, where she teaches Business Associations, Professional Responsibility, and Poverty Law. In 2019, Michele joined the California Blockchain Working Group as a Member. She has published extensively on topics including judicial ethics in immigration and juvenile courts, the substantive due process rights of foster youth, and the rights of shareholders.

Where are they now? After his Fellowship ended, Pablo became a Family Law Attorney at Neighborhood Legal Services of Los Angeles County, where he represented domestic violence survivors in family law matters. He continued to practice law focused on protecting the rights of children with special needs as an Associate Attorney at the Law Offices of Bonnie Z. Yates, and later as a Senior Associate Attorney at Woodsmall Law Group. Pablo is currently the Director of Legal Services at 1736 Family Crisis Center where he represents victims of domestic violence. He also has his own practice where he represents individuals and families in matters involving Immigration, Family Law, Special Education, and Wills and Trusts.

In 2007, she moved to Oregon to become a Staff Attorney at Legal Aid Services of Oregon. In 2009, she became a Commissioner for the Family Services Review Commission and joined Disability Rights Oregon, where she worked as an attorney. In 2014, she became the Director of Equal Opportunity and Deputy Title IX Coordinator at Oregon State University, where she worked to advance inclusion in the increasingly diverse Oregon State University community by ensuring university compliance with all federal and state anti-discrimination laws. Yesinia is currently the Director of Affirmative Action and Equal Opportunity as well as the Deputy Title IX Coordinator at Portland State University.

Where are they now? Following her Fellowship, Amy worked as an Associate Deputy Attorney at the Alameda County Public Defender's Office. Amy is currently a solo practitioner working as a Juvenile Dependency Appellate Attorney in the San Francisco Bay Area.

#### JESSICA STEINBERG

Issue Area: Housing/Homelessness

**Project Description:** Provide legal representation and policy advocacy aimed at increasing the supply of affordable housing in San Mateo County.

Where are they now? After her Fellowship, Jessica worked as a Deputy City Attorney for the City of Salinas, California, where she litigated civil rights and liability claims on behalf of the city in state and federal court. She later served as the Jay M. Spears Fellow and Clinical Lecturer in Law in the Community Law Clinic at Stanford Law School, where she supervised students handling housing, employment, public benefits, and criminal records expungement cases and litigated housing policy matters. In 2011, Jessica joined the faculty at George Washington University in Washington, DC. There, she serves as an Associate Professor of Clinical Law where she directs the Prison & Reentry Clinic. Her scholarship focuses on access to justice with a focus on new models for court reform and the delivery of legal services to the poor. She has received the California State Bar Foundation's Public Interest Award in recognition of her achievements and commitment to public service work, and she is a member of the American Association of Law Schools' Poverty Law Section Executive Committee.

Where are they now? Susan remained with the Children's Law Center of Los Angeles after her Fellowship as a Staff Attorney. She then became Policy Director of the Children's Law Center of California, a position she still holds. In May 2009, Susan Co-Founded the nonprofit Happy Trails for Kids, which provides enriching outdoor adventures to abused and neglected children in the Southern California Foster Care System.

Where are they now? After her Fellowship ended, Myra remained at Lawyers for Children, Inc. She currently works as the Director of the Immigration Rights Project at Lawyers for Children, Inc. and continues to work to protect the rights of undocumented immigrant children in foster care.

**Project Description:** Create an innovative, efficient, and sustainable program for delivering legal services to detained non-citizen children.

Where are they now? After her Fellowship ended, Kristin remained at the Rocky Mountain Immigrant Advocacy Network, where she served for eight years as the Managing Attorney of the Children's Program. She then served as an immigration attorney contracted to The Law Office of Jessica Kunevicius. In 2016, she began working with Kelly Ryan Law LLC, a Denver firm that focuses on immigration. She presents on the topics of law and immigration to youth across the state of Colorado.

#### **RITU GOSWAMY**

Issue Area: Children/Youth

**Project Description:** Create and direct in-house legal services at Homeboy Industries, a gang intervention program in LA that provides jobs, job placement at other organizations, tattoo removal, job training, counseling, GED preparation, and life skills training.

Where are they now? After her Fellowship, Ritu opened her own firm, Holistic Legal Services, based in San Jose and Santa Cruz, California, where she specializes in immigration and citizenship law and holistic legal services. She helps individuals and families of immigrants with their legal status in the United States. She has successfully obtained visas, permanent residency, and citizenship for her clients who come to the United States from all over the world. She also defends immigrants in deportation proceedings and helps immigrants who have been convicted of crimes. Ritu is the former Chair and current Board member of the Santa Clara Valley Chapter of the American Immigration Lawyers Association and is also a member of the Santa Clara County Bar Association and the South Asian Bar Association.

#### JENNIFER PODKUL

Year: 2006

Host Organization: Ayuda, Inc.

City/State: Washington, DC

Issue Area: Children/Youth

**Project Description:** Provide legal representation to child victims of trafficking and other violent crimes. Children are regularly trafficked for forced labor in domestic service, agriculture, textiles, prostitution, restaurants, and other sectors.

Where are they now? After the completion of her Fellowship, Jennifer spent another two years at Ayuda as a KIND Fellow. While at Ayuda, she created and managed the first project designed to provide legal representation to trafficked children, and advocated for policies designed to protect vulnerable immigrant populations. Jennifer then worked as an immigration attorney representing both detained and non-detained immigrants before the US government along the US/Mexico border and in the DC area. Jennifer then became a Program Officer for the Detention and Asylum Program at the Women's Refugee Commission in Washington, DC, where she advocated for the protection of women, children, and families seeking asylum in the United States. She then became the Senior Program Officer for the Migrant Rights and Justice Program at Women's Refugee Commission, where she researched issues facing vulnerable migrants seeking protection in the United States and advocated for improved treatment. In 2016, Jennifer joined KIND as Director of Policy. Jennifer is currently the Vice President for Policy and Advocacy at KIND.

Jennifer is a national expert on issues involving immigrant children, and has published articles, reports, and handbooks on U.S. immigration law. She co-authored "Forced From Home: The Lost Boys and Girls from Central America" and was a contributing author to "Childhood, Migration, and Human Rights in Central and North America: Causes, Policies, Practices, and Challenges." She also regularly presents on the topic. Jennifer has also taught child migration at Georgetown Law Center's Human Rights Institute.

#### **CLAIRE RAMSEY**

**Project Description:** Improve access to childcare issues for children up to three years of age.

Where are they now? After her Fellowship ended, Claire continued at Child Care Law Center as a Staff Attorney working on disability issues and childcare. She worked as part of a project called the "Child Care Inclusion Challenge Project," an interdisciplinary collaboration working to improve access to childcare for children with disability and special health care needs. She was a Staff Attorney at the Legal Aid Society of San Mateo County, where she worked on senior legal issues, including elder abuse, Social Security, SSI, and other government benefits. Claire joined ADZ Law in 2015 where she worked until joining Justice in Aging's Health Care team in 2016. She is currently a Senior Staff Attorney there.

#### EMILY BERGER

Issue Area: Children/Youth

**Project Description:** Provide legal advocacy, outreach, and education to high-risk youth aging out, or about to age out, of the Los Angeles County foster care system.

Where are they now? Emily is currently a Supervising Attorney at the Law Offices of Marlene Furth, which is affiliated with the nonprofit organization Los Angeles Dependency Lawyers (LADL). LADL's four law firms represent parents in juvenile dependency proceedings in Los Angeles County. When a petition is filed in court, LADL lawyers are appointed to represent parents in the case. LADL and its 109 lawyers are committed to keeping families together; their goal is to always advocate for the client's right to retain or regain custody of his or her child.

# ALEXIS FANOUS (MCLEOD)

Host Organization: Public Law Center

City/State: Santa Ana, CA

Issue Area: HIV/AIDS

**Project Description:** Improve the lives of those living with HIV/AIDS by anticipating their potential legal issues through legal checkups, while providing direct legal services, advocacy, and outreach.

Where are they now? After her Fellowship, Alexis continued to oversee her project at the Public Law Center before accepting a position as a Legal Fellow at the International Justice Mission. During her time there, she assisted in the criminal prosecution of sex trafficking and forced prostitution offenses under India's Prevention of Immoral Trafficking Act and Penal Code; conducted extensive legal research and drafted briefs on procedural, substantive, and evidentiary issues; drafted trial briefs, motions, and internal memoranda; prepared witnesses to testify and assisted the Legal Director in managing the team of national staff attorneys. In July of 2011, Alexis became the Director of Development at My Friend's Place in Hollywood, California. Founded in 1988, My Friend's Place is a nonprofit resource center offering a comprehensive continuum of care that includes free emergency resources such as food and clothing in combination with health, educational, and therapeutic services to over 1,600 homeless youth and their children each year. From 2014 until 2017 Alexis worked as a freelance grant writer until starting as an attorney at Family Building, a professional Law Corporation in February 2017.

#### **FIZA QURAISHI**

Issue Area: Children/Youth

**Project Description:** Provide direct representation for foster youth with unmet mental health needs.

Where are they now? Following her Fellowship, Fiza continued to work for several years as a Staff Attorney at National Center for Youth Law (NYCL), specializing in Juvenile Justice Reform. She promoted systemic reforms and strategies that keep youth from entering the juvenile justice system and helped create community-based treatment programs.

In February of 2016, Fiza passed away at the age of 37 from brain cancer. She is remembered as an amazing lawyer and advocate who helped improve the lives of thousands of children. NYCL and her alma mater, the University of Michigan Law School, created the Fiza Quraishi Youth Law Fellowship in her memory; its purpose is to "allow young attorneys who share her spirit to follow in her footsteps and continue to fight on behalf of disadvantaged children."

**Issue Area:** Education

**Project Description:** Provide legal services and advocacy for teens transitioning or aging out of foster care in New York City to ensure that their educational and vocational needs are met with appropriate services.

Where are they now? Alice remained at Advocates for Children of New York after her Fellowship as a Staff Attorney. She is currently a Staff Attorney at the Center for Children's Advocacy, where she leads a medical-legal partnership project at Yale-New Haven Hospital.

Issue Area: Immigrant Populations

**Project Description:** Provide outreach services, legal advocacy, and independent living skills education to abuse, abandoned, or neglected undocumented children in San Diego.

Where are they now? Courtney has remained at the Legal Aid Society of San Diego since her Fellowship ended. She is currently a Pro Bono Staff Attorney working on the Income Maintenance team. She also works as an Associate Attorney with San Diego Elder Law Center. Courtney is a member of the National Academy of Elder Law Attorneys, a member of the legal community supporting California Advocates for Nursing Home Reform, and secretary of the Board of Directors for San Diego Planning Partnership.

**Project Description:** Provide legal advocacy, representation, and outreach for the general special educational needs of children living in foster care in New York City as a law guardian at Lawyers for Children.

Where are they now? Laura remained with Lawyers for Children in New York, where she works as the Legal Director of the Education Advocacy Project.

**Project Description:** Empower low-income residents and teen youth, primarily Latino immigrants, through capacity building activities, advocacy, and community legal and social education.

Where are they now? Kristi remained at Legal Services of Northern California after the completion of her Fellowship. She served as a Staff Attorney focusing on elder law issues and coordinated a new program that provides information and assistance to senior citizens in Yolo County. She then started her own law practice with a focus on estate planning, wills, and trusts, where she remains today.

Issue Area: Children/Youth

**Project Description:** Provide education, immigration, and dependency advocacy for unaccompanied, Spanish-speaking youth in the Bay Area through direct representation, policy advocacy, training, and outreach.

Where are they now? Following her Fellowship, Hayley continued to work at Legal Services for Children in San Francisco, where she represented primarily immigrant youth in dependency proceedings, probate guardianships, school discipline hearings and immigration cases. She remained at Legal Services for Children until May 2017, and became a Senior Staff Attorney at the organization. In May 2017, Hayley became a Deputy Public Defender at the recently-formed Immigrant Defense Unit of the San Francisco Public Defender's Office.

**Project Description:** Change early intervention and early childhood special education services in DC by representing families to enforce their right to quality and timely services.

Where are they now? Following her Fellowship, Renee continued as a staff attorney at Children's Law Center Healthy Together medical-legal partnership, which brings lawyers and physicians together in city health clinics to tackle legal issues that underlie problems in child health and wellbeing, including special education, housing conditions, and access to health care services. Renee then transitioned to a Supervising Attorney on the Children's Law Center's Policy team, where she advocated with DC government agencies and the DC Council to improve services and supports for the District's most vulnerable children and families, including children with needs for special education. In November 2018, Renee became the Managing Attorney for Advocates for Basic Legal Equality in Dayton, Ohio.

**Project Description:** Provide proactive, community-based civil legal representation to New York's indigent youth as they take the arduous journey from courthouse to community.

Where are they now? Following his Fellowship, Michael continued at Youth Represent. In 2015, he was promoted to Legal Director and, in 2019, to Executive Director. He continues to represent youth on all reentry matters including legal representation in criminal, civil, housing, and family court.
